Locust Street Sewer Project – Ossola announced that the project and site restoration have been completed.

Grivetti informed the board that Doug (Superintendent Englehaupt) had contacted him about pricing on Christmas lights for the park and the Main Street trees. Doug requested and received permission from Grivetti to order the lights from Debo's so they would be in on time for use this year.

Motion Cattani – Second Martin to purchase Christmas lights from Debo's for an amount between \$2,200 and \$2,500.

<u>Computer & Desk</u> – Gaefcke reported that the cost of the items for his office were approximately \$850.00. <u>New Hires</u> – Gaefcke announced that 2 new candidates for the Police Academy have been hired. Of the candidates, one has failed the physical fitness test so he will not continue on. <u>Chevy Impala</u> – Bids are being accepted on the old Chevy squad car. <u>Police</u> Interceptor – The new vehicle in 98% finished needing only striping and some electronic work done.

Grivetti informed the board that the Plan Commission met prior to the Board meeting and have recommended approval of Vince Coughlin's variance request.
