2019-07-23 MINUTES

The Ladd Village Board met in Regular Session at 6:30pm on Tuesday, July 23, 2019, in the Village Hall. President Mike Grivetti called the meeting to order and led the Pledge of Allegiance to the American flag.

Motion Cattani – Second Manning to accept the (July 9, 2019 meeting) minutes, as presented.

Kim Bird of Hopkins & Associates presented the Village's audit report for Fiscal Year 2019. She prepared a Board handout which summarized the fund balances and recommended a transfer of funds into the Water & Sewer funds which have deficit balances. She reported that the Village is in a good position overall.

Engineer's Report: Motor Fuel Tax (MFT) Program – Ossola reported that the chip seal program would begin during the week of July 29th. Ladd Community Center parking lot – One of the options for the maintenance of the lot is to have the MFT contractor apply a coat of oil & chips. The cracks can be sealed at a later date. Ossola requested that the contractor hold the same unit prices as for the street program but they have not committed to that yet. He estimates the job at those prices would cost \$2,500 or less.

Motion Manning – Second Cattani to authorize Ossola to arrange for the paving of the Ladd Community Center parking lot for up to \$3,000.

An estimate to crack seal and seal coat the asphalt tennis courts was reviewed. The item was tabled until Spring 2020.

Inspector's Report: Fencing Regulations – Flanagan reported that he had received fencing information from Barry. He requested and received additional time to review it before any changes are made to the ordinance.

Attorney's Report: <u>Village Fees</u> – An ordinance to increase certain Village fees was tabled until the August 13th meeting. <u>Ameren Agreement</u> – Barry reported on a meeting with Ameren representatives to discuss the pole attachment agreement. He will make a few small changes and present it for Board approval.

Since no additional quotes were received to remove and replace the manhole behind the water tower, no action was taken.

Motion Martin – Second Urbanowski to accept the Plan Commission's recommendation to approve Colby Fordham's variance request (to increase the height of a fence located in a side yard from 4' to 6') at 207 South Central Avenue.
