Source of Water: LADDBased on information obtained in a Well Site Survey published in 1989 by the Illinois EPA, no potential sources are located within 1,000 feet of the wells. The Illinois EPA has determined that the Ladd Community Water Supply's source water is susceptible to contamination. This determination is based on a number of criteria including; monitoring conducted at the wells; monitoring conducted at the entry point to the distribution system; and available hydro geologic data on the wells.
