**AN ORDINANCE AMENDING
SECTION 8.28.010 OF THE MUNICIPAL CODE
OF THE VILLAGE OF LADD, BUREAU COUNTY, ILLINOIS
RELATING TO OUTDOOR BURNING**

WHEREAS, the Municipal Authorities of the Village of Ladd, Bureau County, Illinois, have previously enacted ordinance(s) codified in Chapter 8.28.010, of the Municipal Code of the Village of Ladd, Bureau County, Illinois, relating to outdoor burning; and

WHEREAS, the Municipal Authorities of the Village desire to amend the days in which residents are authorized to burn leaves and other landscape waste in the Village of Ladd,

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LADD, BUREAU COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE: Prohibited Exceptions. That the existing of Section 8.28.010 of the Municipal Code of the Village of Ladd, Bureau County, Illinois, be, and the same is, hereby deleted in its entirety and the following, revised Section 8.28.010 is hereby substituted in its place:

8.28.010 Prohibited—Exceptions.

No person, firm or corporation shall burn any trash, papers, rubbish, garbage, refuse, construction debris or building materials anywhere within the Village of Ladd, Bureau County, Illinois. However, leaves and other landscape waste only, and only if generated from vegetation on the premises where being burned or any contiguous lot owned by the same owner(s), may be burned between the hours of eight (8) a.m. and six (6) p.m., and only on Tuesdays, Thursdays and Saturdays. The burning of leaves and other landscape waste at any other time is hereby strictly prohibited. The open burning of leaves and other landscape waste shall be permitted on public rights-of-way, except on sidewalks, roadways, alleys, parking lots or other paved areas within those rights-of-way. No burning shall be permitted within twenty (20) feet of any structure. All fires shall be constantly attended by a competent person until each fire is fully extinguished. The Fire Chief for the Village's Fire Protection District shall have authority to prohibit burning when atmospheric conditions, other conditions or the location of any fire in the Chief's sole opinion constitutes a

hazard. Open campfires of clean, non-construction timber and kindling are hereby exempted from the prohibitions of this Section.

SECTION TWO: Severability If any section, clause, provision or portion of this Ordinance is adjudged unconstitutional or invalid by a Court of competent jurisdiction or by any agency of any kind or by anyone else, the remainder of this Ordinance shall not be affected.

SECTION THREE: Repeal

All ordinance or parts of ordinances in conflict with this Ordinance are hereby repealed insofar as they are in conflict with this Ordinance.

SECTION FOUR: Invalidity

If any provision of this Ordinance or its application to any person or under any circumstances is adjudged invalid, such adjudication shall not affect the validity of the Ordinance as a whole or of any portion not adjudged invalid.

SECTION FIVE: Effective Date

This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
