**AN ORDINANCE AMENDING CHAPTER 13.19.040
OF THE MUNICIPAL CODE OF THE VILLAGE OF LADD, BUREAU
COUNTY, ILLINOIS, ESTABLISHING A FINE FOR FAILURE
TO RETURN A CROSS CONNECTION SURVEY**

WHEREAS, the Municipal Authorities of the Village of Ladd, Bureau County, Illinois, have previously enacted ordinance(s) codified in Chapter 13.19.040 of the Municipal Code of the Village of Ladd, Bureau County, Illinois relating to a cross-connection control program for the Village's water supply system; and

WHEREAS, the Municipal Authorities of the Village desire to add a fine to said Section for a customer's failure to return the cross-connection survey required by said program,

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LADD, BUREAU COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE: Fine That the existing Section 13.19.040 of the Municipal Code of the Village of Ladd, Bureau County, Illinois, be, and the same is, hereby repealed and the following, revised Section 13.19.040 is hereby substituted in its place:

13.19.040 Local cross-connection control program.

The Village shall develop a comprehensive control program for the elimination and prevention of all cross-connections, and the removal of all existing cross-connections and prevention of all future cross-connections. Said program shall require each residential and commercial water customer to complete and return a cross-connection control survey every two years on a form approved by Village authorities for that particular class of customer. Any customer who fails to complete and return said survey form by the deadline set forth in a first notice sent to said customer for failure to return the form in a timely manner shall be fined the sum of Fifty and no/100 Dollars (\$50.00). Said fine shall be added by the Village Clerk to that customer's next water bill. Any customer who fails to complete and return said survey form by the deadline set forth in a second notice sent to said customer for failure to return the form in a timely manner shall be subject to disconnection as directed by the General Superintendent of the Village.

SECTION TWO: Severability If any section, clause, provision or portion of this Ordinance is adjudged unconstitutional or invalid by a Court of competent jurisdiction or by any agency of any kind or by anyone else, the remainder of this Ordinance shall not be affected.

SECTION THREE: Repeal

All ordinance or parts of ordinances in conflict with this Ordinance are hereby repealed insofar as they are in conflict with this Ordinance

SECTION FOUR: Invalidity

If any provision of this Ordinance or its application to any person or under any circumstances is adjudged invalid, such adjudication shall not affect the validity of the Ordinance as a whole or of any portion not adjudged invalid.

SECTION FIVE: Effective Date

This Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
